## **VOLUNTEERING:**

1. All families are expected to volunteer and provide a \$100 deposit (one deposit per family) in advance, payable with registration fees.
2. The volunteer deposit will be returned only if the volunteer commitment of a minimum 5 hours has been fulfilled. Refunds will be made twice (2X) a year, after the end of July and in December.
3. We encourage every family to volunteer but there is an option if you just don't think you will be able to. Select "I do not wish to volunteer" but when volunteers cannot be found, emails will be sent to all families.
4. Please note that choosing "As Required" as our volunteer role means that you may be contacted to volunteer for ANY NHCA event or program. ## **REFUND POLICY:**

## **INFORMATION RELEASE WAIVER (2015):**

The following are examples of how personal information on the soccer registration form may be used and disclosed for soccer related activities and are not intended as an all-inclusive list. These activities form a vital part of a healthy and functioning organization and the participation of all registrants in these activities is viewed as an important part of every player's enjoyment and development in soccer.

1. The use of a registrant's name for the identification of assigned teams.
2. The use of a registrant's name, address, telephone number, email address, birth date, parents'/guardians' name, address, telephone number, and email address for player identification purposes for soccer related activities.
3. The use of a registrant's name, address and related contact information for the purpose of acquiring voluntary assistance.
4. The use of a registrant's name, telephone number, and related contact information for changes to schedules and other soccer related activities.
5. The use of a registrant's name and photo for athletic events and sport related information for community newsletters or other soccer related publications.
6. The use of individual, team, or group photos taken during a soccer related event for display during soccer related functions.
7. The use of photos/videos, taken by a member of NHCA Soccer for educational/promotional purposes relating to the game of soccer.
8. The use of a registrant's name and any health and/or related personal information to assist authorized individuals in responding to emergency situations and to assist the players who have a medical or other condition.

Please note: Photos, videos or images of players attending or participating in a soccer activity that are open to the general public may be taken by the general public and used for purposes within and outside NHCA Soccer.

Parents are under no obligation to consent: it is their voluntary decision to do so. This consent remains valid for the current soccer season only.

I being the parent/legal guardian have read and understand the information provided. By agreeing with the statement and continuing with on-line registration I hereby voluntarily consent to the use and disclosure of the specified personal information as noted above.

**NHCA Children’s Soccer Program Policies**

- Parent(s), or a designated caregiver; whether a babysitter or friend that is carpooling; should be at the soccer field while a child is participating in soccer. While this is a non-competitive league, there is still a possibility of injury, and someone known to the child should be available.
- The NHCA and its’ volunteers will make every effort to place children on teams with their peers; however this might not always be possible. In addition, we cannot accommodate playing field requests.
- When registering your child or children in soccer, please ensure a valid email address is included in the PLAYER’S EMAIL text box on the registration form. Due to the Soccer Manager software program being used, email is a primary method of contact by coaches and team managers.
- Children must play in the Age Group assigned to their year of birth. By parental request, a child can be moved up to an older age group, but NOT down.
- Proof of age will now be required for the U12 Girls and U12 Boys division. Our registration software calculates eligibility by YEAR OF BIRTH. If your child turns 13 in this year, they are considered ineligible to play U12 soccer. This document must be brought within the first week, otherwise the child will not be allowed to play. If a child playing in U12 is older than 12 years of age, a refund will be given, less a 20% administration fee.
